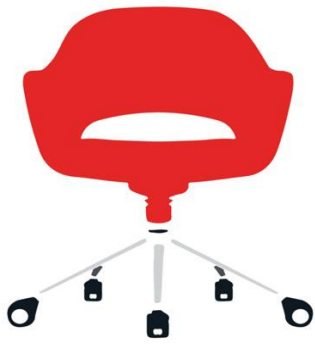

Warranty:

1. Woodstock warrants to the original purchaser all components for a period of 10 years, from date of shipment, with the exception of upholstery and foam which is warranted for 3 years. The warranty covers normal use. Material that is damaged on site by cutting or hitting an object is excluded. Special care should be taken when unboxing our products, do not use a knife.
2. Woodstock warrants to the original purchaser that all parts will be free from material defects. Woodstock will repair or replace, at its option, any unaltered components.
3. Warranty is limited to a forty hour, 7-day work week and 300 pound weight limit. See individual chair descriptions for any deviations to weight limits. Use of our chairs at any auto dealership 100% voids warranty.
4. Warranty is limited to replacement or repair in the contiguous United States and does not cover cost of dealer transportation or labor. Photos of warranty issue may be requested.
5. Warranty for concealed damage or claim for incorrect product must be made within 7 calendar days of receipt of product, to ship to address noted on PO. Delayed unboxing/assembly or installation will be at risk to Dealer.
6. Warranty does not cover chairs getting dirty, stained or damaged by chairs coming in contact with sharp objects/ sharp edged furniture. Small wrinkles in leather/nappa/mesh/fabric are normal and can be expected.
7. Chairs shipped in leather/nappa/mesh/fabric upholstery may be different from one another due to different types of material color lots. Pilling of upholstery or changes in colorfastness to materials, due to aging, exposure to light, direct sunlight, soiling, stains, abrasion or other materials, is not a covered warranty item.
8. Woodstock shall not be liable for loss of time, consequential or incidental damages from any product defect.
9. There are no other warranties expressed or implied other than those specifically described.

Dyes from jeans and other clothing may transfer to upholstery, especially lighter colored upholstery. This is a problem with all manufacture's products, not just Woodstock chairs. Leather/nappa/mesh/fabric upholstery staining from dyes or other sources of stains, isn't a warranty item. Keeping any leather/nappa/mesh/fabric lighter colored upholstery perfectly clean, during use, is difficult. While we offer recommend cleaning for all of our various upholsteries, we can not warranty that every stain from customer use will be able to be removed.

Please consider the above inherent issues with various upholsteries, when placing your orders.

Shipping:

We DO NOT offer Call Before Delivery. We generally ship orders within 48 business hours providing:

1. Orders are received during normal business hours 9AM - 4PM EST
Monday - Friday, excluding holidays.
2. Chairs are in stock at the time of order
3. Non Stock chairs deliver in approximately 12-14 weeks
Non-shipment due to acts of God are beyond our control.

Please note that although our shipment methods include FedEx and LTL, your order will be shipped via the best determined method based on time and quantity. Prices for items requiring LTL shipment are paid to a commercial loading dock, that can accommodate a 53' truck/trailer. If LTL shipment is to a residential address, address with limited truck access, requires a liftgate service or no loading dock call, Customer Service for LTL Freight Quote to be added to the cost of the item(s).

Terms of Sale:

1. Terms after credit approval: Net 30 days with dollar limit, unless otherwise noted. We also accept VISA, Mastercard, Discover & American Express for payments. Credit card payments will carry a 3% additional processing fee.
2. Shipping is included in all table and chair pricing. Order for parts only, will have a special shipping quoted fee. Shipping is to lower 48 states. If shipping is FOB, that is a price from our warehouse location.
3. Orders normally ship within 48 hours, unless requested otherwise on PO.
4. All internet dealers advertising our products must follow our MAP pricing program in your advertisements or on your website.
5. We have a customer care department that is set up to answer your customer's questions about product, assembly or warranty concerns. Phone # is 866-574-3183.
6. We will acknowledge all orders. We invoice you the day before shipment is planned.
7. Most chairs & tables require some assembly and are not shipped fully assembled. See assembly instructions on product pages. Our products should arrive approximately 2-5 business days, to you, after our shipment from warehouse. We generally ship via FedEx ground service or LTL.
8. We do not charge for drop shipments.
9. For shipping outside the lower 48 states, contact customer care for special costs. Special handling, delivery or special shipping requests may incur additional costs to buyer. For shipments to Alaska, Hawaii or Puerto Rico, please contact Customer Care.
10. Changes or order cancellations can not be accepted after an order has transmitted to warehouse for preparation for shipment and/or actually shipped.
11. Special quoted projects can not be cancelled, once a deposit has been received.
12. Return of product requires first that you obtain a Return Authorization (RA) from us:
Chair/Table must be:
 1. Product must have been delivered to you within 14 calendar days. After 14 days, no return is allowed.
 2. In the original unopened carton. We will request photos from you.
 3. Chair/table must be packed so there is no damage. Carton will be inspected by us upon receipt.
 4. Dealer responsible for original \$40 freight of item to you and the return freight carrier/costs of your choice.
 5. We charge a mandatory 40% restocking fee.
 6. Return must be received by Woodstock within 14 calendar days of issuance of the RA.
13. Warrantee claims: See Warranty section for details.
14. Woodstock reserves the right to make small modifications to chairs/tables as necessary due to supply chain changes beyond our control, such as changes to mechanism & handles, gas cylinders, screws, castors, etc.
15. Discontinued items may not be able to be replaced, due to inventory no longer being available.
